**AUTHORIZING ADVERTISEMENT FOR BIDS FOR FOUNDATION AND SITE WORK FOR
MODULAR FIRE TRAINING SIMULATOR PROJECT #OFC2017-004**

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, has determined that they will advertise for sealed bids for Foundation and Site Work for Modular Fire Training Simulator - Project #OFC2017-004;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, as follows:

1. Detailed specifications will be provided to perspective bidders to assure the work obtained through this bid will meet the requirements of the project.
2. Bids to be submitted shall fully comply with the specifications.
3. The Commissioners shall advertise for the receipt of sealed bids for the above-named purpose or project.
4. Each bid shall be submitted as a written proposal in manner designated in the specifications and shall be signed by the bidder. The bid shall be enclosed in a sealed envelope bearing the name and address of the bidder on the outside, specifically denoting on said envelope the name of the project for which said bid is submitted and addressed to Don Dougherty, Purchasing Agent, Cherry Hill Fire District #13, 1100 Markkress Road, Cherry Hill, New Jersey 08003.
5. Specifications and form of bid may be inspected or obtained upon proper notice by prospective bidders during normal business hours from Purchasing Agent, Don Dougherty, Cherry Hill Fire District #13, 1100 Markkress Road, Cherry Hill, New Jersey 08003, (856) 795-9805.
6. Sealed bids shall be called for and shall be received, opened and read in public at the place and time specified in the Notice to Bidders.
7. Said bids shall be delivered at the time and place stated above. No bid shall be delivered or accepted after the date and hour designated.
8. The bid quote shall be net to the Commissioners and shall be excluded from any state or federal taxes.
9. The contract will be awarded to the lowest, qualified, responsible bidder. The Commissioners also reserve the right to waive any insubstantial irregularities in any bid.

10. A non-collusion affidavit in the usual form will be supplied with the specifications. It shall be executed by the person or corporate officers submitting the bid. Said affidavit must be properly notarized. A non-collusion affidavit must accompany each bid. THIS REQUIREMENT WILL NOT BE WAIVED.
11. An owner's list in accordance with P.L. 1977, c.33, approved March 8, 1977, will also be supplied with the specifications in the usual form. It shall be completed by the person or corporate officers submitting the bid. Said owner's list must accompany each bid. THIS REQUIREMENT WILL NOT BE WAIVED.
12. Bidders are required to comply with the applicable Statutory requirements and regulations adopted pursuant thereto, including but not limited to P.L. 1975, c.127; P.L. 1977, c.33; P.L. 1963, c.150; and P.L. 1993, c.277, including all amendments thereto.
13. No bidder may withdraw his proposal for a period of 60 days after the opening of the bids; all proposals being binding upon the bidders for said 60-day period.
