RESOLUTION APPOINTING AN EMS LIEUTENANT NOV 3 2016

WHEREAS, N.J.S.A. 40A:14-81.1 states that the Commissioners of a Fire District may, by resolution, establish paid positions for the Fire District as such positions shall be determined by the Commissioners to be required for the purposes of the Fire District; and

WHEREAS, the Board of Fire Commissioners, District #13, Cherry Hill, New Jersey has determined that the position of EMS Lieutenant of the Fire District and the salaries and benefits for such positions have been previously established, and;

WHEREAS, the Board of Fire Commissioners has determined that an EMS Lieutenant position needs to be filled to continue to promote the safety of the public they serve, and;

NOW, THEREFORE BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey that the Board of Fire Commissioners is hereby authorized to appoint MICP Gregory S. Allen as EMS Lieutenant effective November 7, 2016.

BE IT FURTHER RESOLVED, by the Board of Fire Commissioners, District #13, that the individual appointed to the position of EMS Lieutenant of the Fire District shall be subject to a review twelve months following the date of appointment by the Fire Chief who shall have full and final discretion and authority to conduct this review and make recommendations subject to review and approval by the Board and pursuant to the provisions of N.J.S.A. 40A: 14-70 et seq.
