**RESOLUTION AUTHORIZING CHERRY HILL FIRE DISTRICT #13 TO ENTER INTO A  
COOPERATIVE PRICING AGREEMENT WITH THE CHERRY HILL COOPERATIVE PRICING  
SYSTEM – IDENTIFIER #37-CHCPS**

**WHEREAS**, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

**WHEREAS**, the Township of Cherry Hill, hereinafter referred to as the "Lead Agency " has offered voluntary participation in a Cooperative Pricing System for the purchase of goods and services and non-commodity items; and

**WHEREAS**, pursuant to N.J.A.C. 5:34-7.5(f), the term of the Cooperative Pricing System will commence on May 12, 2016 and will terminate May 12, 2021 as approved by the Director of the Division of Local Government Services; and

**WHEREAS**, on June 2, 2016 the governing body of Cherry Hill Fire District #13, County of Camden, State of New Jersey duly considered participation in a Cooperative Pricing System for the provision and performance of goods and services and non-commodity items.

**NOW, THEREFORE BE IT RESOLVED** as follows:

**TITLE**

This Resolution shall be known and may be cited as the Cooperative Pricing Resolution of Cherry Hill Fire District #13.

**AUTHORITY**

Pursuant to the provisions of *N.J.S.A. 40A:11-11(5)*, the Mayor is hereby authorized to enter into a Cooperative Pricing Agreement with the Lead Agency.

**CONTRACTING UNIT**

The Lead Agency shall be responsible for complying with the provisions of the *Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.)* and all other provisions of the revised statutes of the State of New Jersey.

**EFFECTIVE DATE**

This resolution shall take effect immediately upon passage.
