RESOLUTION AUTHORIZING 2 YEAR CONTRACT EXTENSION FOR  
EMS MEDICAL BILLING SERVICES PROJECT #EMS2014-001

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, wishes to extend an existing contract entitled EMS Medical Billing Services, Project #EMS2014-001 for an additional two (2) years in accordance with Local Public Contracts Law NJSA 40A:11-4.2 and a provision in the original contract; and

WHEREAS, the Board of Fire Commissioners has determined that the services being provided under this existing contract are being performed in an effective and efficient manner as required by Local Public Contracts Law NJSA 40A:11-15; and

WHEREAS, the existing vendor has agreed to continue providing these service based upon the conditions of the original contract for the same flat compensation rate of 4.5% for this two year extension;

NOW THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, Fire District #13, that a contract extension be prepared and awarded to DM Medical Billings, LLC, 20 East Taunton Road, Suite 500, Berlin, NJ for the flat compensation rate of 4-1/2% of net cash collected.

BE IT FURTHER RESOLVED that notice of this award shall be publish in the official newspaper summarizing the award of the contract with a statement that this resolution and contract are on file and available for public inspection.
