**RESOLUTION AUTHORIZING ORDERING OF TWO (2) AEV FORD E-450 BASED TYPE III  
AMBULANCES PROJECT #HGAC2018-001 USING HGAC  
COOPERATIVE PURCHASING PROGRAM**

**WHEREAS**, the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, has determined that a need exists to order two (2) Type III Ambulance for use by the Department; and

**WHEREAS**, the Fire District is a member of the Houston-Galveston Area Council Cooperative Purchasing Program which can be utilized to order ambulances through their fair and open process that satisfies the requirements of the Local Public Contracts Law, N.J.S.A. 40A:11 et seq. without further competitive bidding; and

**WHEREAS**, the AEV TYPE III, FORD E450 TRAUMAHAWK 164" with various published and unpublished options described in the attached HGAC Contract Pricing Worksheet, product code AA13 meets the standards, specifications and requirements of the Cherry Hill Fire Department;

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, that an order for two (2) ambulances that meet the requirements of Project #HGAC2018-001, Ordering Two (2) AEV Ford E-450 Based Type III Ambulances, in the amount of \$365,940.00, be placed with VCI Emergency Vehicle Specialists, 43 Jefferson Avenue, Berlin, NJ 08009 under the provisions of the Houston-Galveston Area Council Cooperative Purchasing Program Contract #AM10-16.

**BE IT FURTHER RESOLVED** that this order will be funded using a forty-eight (48) month Operating Lease which will be established through a separate bid. In accordance with N.J.A.C. 5:34-3.3 (d) et seq., the Operating Lease shall contain a clause making the agreement subject to the availability and appropriation annually of sufficient funds as may be required to meet the extended obligation.
