**RESOLUTION AUTHORIZING THE DISPOSAL OF SURPLUS FORD EXPEDITION
NO LONGER NEEDED FOR PUBLIC USE**

WHEREAS, the Fire District from time to time has equipment and other materials which become unusable by the organization due to obsolescence, wear and tear, or other reasons which must be disposed of as surplus property; and

WHEREAS, the Fire Chief has determined that the 2001 Ford Expedition, VIN IFNRY16W21LB74712, which is a fire district asset, has become surplus and is no longer needed for public use; and

WHEREAS, N.J.S.A. 40A:11-36 of the Local Public Contracts Law permits the disposal of surplus property through private sale without advertising for bids when the estimated fair market value of the property to be sold does not exceed 15 percent (15%) of the bid threshold in any one sale;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Fire Commissioners, Fire District #13, hereby declares the 2001 Ford Expedition, VIN FMRU16W21LB74712 to be surplus and that it shall be removed from the fire district's list of assets.

NOW, BE IT FURTHER RESOLVED, that the Board of Fire Commissioners, Fire District #13 authorizes the disposal of this vehicle through the internet auction site GovDeals in accordance with the term and conditions established for the sale, sold "as is" and "where is with no warranties implied.


