**RESOLUTION AUTHORIZING TERM PRICING CONTRACT FOR PURCHASE OF  
EMS SUPPLIES PROJECT #EMS2018-001**

**WHEREAS**, the Board of Fire Commissioners, District #13, has a need to procure EMS Supplies in a timely manner; and

**WHEREAS**, the Board of Fire Commissioners, District #13, in accordance with N.J.S.A. 40A:11-1 et seq., the Local Public Contracts Law, has duly advertised bid specifications for a project entitled EMS Supply Pricing, Bid #EMS2018-001 to establish a ready source for the procurement of these supplies; and

**WHEREAS**, after bids had been received and reviewed, lowest pricing for each of the 149 supplies has been determined and the items will be ordered from the resulting six (6) responsive and responsible bidders; and

**WHEREAS**, the Board of Fire Commissioners, District #13, through this resolution intends to establish term pricing contracts with these lowest responsible bidders for this project with no guarantee as to the minimum or maximum volume of purchase;

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, that a Two (2) Year term pricing contract for the bid entitled EMS Supply Pricing, Bid #EMS2018-001 shall be awarded to the following vendors:

**BE IT FURTHER RESOLVED**, that the duration of the term contract between the Board of Fire Commissioners, District #13 and these companies shall be from May 1, 2018 through April 30, 2020; and

**BE IT FURTHER RESOLVED**, that the Board of Fire Commissioners, Fire District #13 authorizes their Purchasing Agent to procure these supplies on an as-needed basis based on the unit prices for the term of this award, pursuant to all conditions of the bid specifications, without any further action; and

**BE IT FURTHER RESOLVED**, that, pursuant to N.J.A.C. 5:30-5.5(b), the Purchasing Agent must notify and seek the certification of availability of funds from the Finance Officer prior to the placing of any orders for goods or services related to this project.
