RESOLUTION TO APPOINT AN EMS LIEUTENANT

WHEREAS, N.J.S.A. 40A:14-81.1 states that the Commissioners of a Fire District may, by resolution, establish paid positions for the Fire District as such positions shall be determined by the Commissioners to be required for the purposes of the Fire District; and

WHEREAS, the Board of Fire Commissioners, District #13, Cherry Hill, New Jersey has determined that the position of EMS Lieutenant of the Fire District and the salaries and benefits for such positions have been previously established and has been created as part of the initiative to address the EMS Officers rank structure, and;

WHEREAS, the Board of Fire Commissioners has determined that one EMS Lieutenant position needs to be filled to continue to promote the safety of the public they serve, and;

WHEREAS, this appointment is contingent on the completion of the following requirements: Pass a background investigation; Pass a Psychological Examination; Pass a Post Offer Medical Examination which includes a Hair Follicle Drug Screening Test; complete all required training as directed by the Fire Chief of the Department.

NOW, THEREFORE BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey that the Board of Fire Commissioners is hereby authorized to appoint MICP Willard Schaub as EMS Lieutenant effective February 15, 2019, and will be sworn in at the February 21, 2019 Board of Fire Commissioners Workshop meeting.

BE IT FURTHER RESOLVED, by the Board of Fire Commissioners, District #13, that the individual appointed to the position of EMS Lieutenant of the Fire District shall be subject to a review twelve month following the date of appointment by the Fire Chief who shall have full and final discretion and authority to conduct this review and make recommendations subject to review and approval by the Board and pursuant to the provisions of N.J.S.A. 40A: 14-70 et seq.
