**RESOLUTION APPROVING THE ANTICIPATED ITEM OF REVENUE AND
APPROPRIATIONS TO THE 2018 FIRE DISTRICT BUDGET – FY18 HAZARDOUS
MATERIALS EMERGENCY PREPAREDNESS HAZ-MAT TRAINING SUBGRANT**

WHEREAS, NJSA 40A:14-78.5 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any Fire District when such item shall have been made available by law and the amount was not determined at the time of the adoption of the budget; and

WHEREAS, Cherry Hill Fire District #13 has applied for the FY18 Hazardous Materials Emergency Preparedness (HMEP) Training Subaward Grant – CFDA 20.703, Sub-Award Number (2018-02) for the period September 30, 2018-September 29, 2019; and

WHEREAS; Cherry Hill Fire District #13 directs and authorizes Fire Chief Chris Callan to act as the official representative of the Fire District in connection with the application and to provide such additional information as may be required.

NOW, THEREFORE, BE IT RESOLVED, that Fire District #13 of the Township of Cherry Hill in the County of Camden, State of New Jersey, hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2019 in the sum of \$18,850.00, which is now available from the U.S. Department of Transportation through the New Jersey Department of Law and Public Safety, Division of State Police, Office of Emergency Management.


