RESOLUTION TO APPOINT A FIRE LIEUTENANT

WHEREAS, N.J.S.A. 40A:14-81.1 states that the Commissioners of any Fire District may, by resolution, establish paid positions for the Fire District as such positions shall be determined by the Commissioners to be required for the purposes of the Fire District; and

WHEREAS, the Board of Fire Commissioners, District #13 Township of Cherry Hill, County of Camden, State of New Jersey has determined that the position of Fire Lieutenant and the salary and benefits for such position has been created and previously established; and

WHEREAS, the Board of Fire Commissioners has determined that a Fire Lieutenant position needs to be filled to continue to promote the safety of the public they serve, and.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey that the Board of Fire Commissioners is hereby authorized to appoint Sean McGowan as Fire Lieutenant effective April 12, 2019 and will be sworn in at the April 18, 2019 Board of Fire Commissioners Workshop meeting.

BE IT FURTHER RESOLVED, by the Board of Fire Commissioners, District #13, that the individual appointed to the position of Fire Lieutenant of the Fire District shall be subject to a review twelve months following the date of appointment by the Fire Chief who shall have full and final discretion and authority to conduct this review and make recommendations subject to review and approval by the Board and pursuant to the provisions of N.J.S.A. 40A: 14-70 et seq.


