**RESOLUTION APPROVING ENTERING INTO LEASE FOR AMBULANCE OPERATING LEASE
FOR ONE AMBULANCE PROJECT #EMS2019-001**

WHEREAS, the Board of Fire Commissioners, District #13, has approved a bid award for a 48 month lease with the Leasing 2, Inc. to arrange an operating lease for an ambulance per a project entitled Operating Lease for Ambulance - Project #EMS2019-001 with a total of payment \$175,351.84; and

WHEREAS, Leasing 2, Inc. has provided an executable Master Lease and Supplements which identifies Wells Fargo Equipment Finance, Inc., 733 Marquette Avenue, Suite 700, MN 55402 as the true Lessor for the lease;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey hereby authorizes the Chief Finance Officer to execute a Master Lease and Supplements with Wells Fargo Equipment Finance, Inc., 733 Marquette Avenue, Suite 700, MN as the lessor and to acknowledge and deliver the Lease Agreement with any changes, insertions and omissions therein as may be approved by the Officer and such approval to be conclusively evidenced by such execution and delivery of the Lease Agreement.

BE IT FURTHER RESOLVED that this agreement shall be subject to and dependent on the annual appropriation of sufficient funds as may be required to meet this obligation.


