**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR IT SUPPORT SERVICES WITH ROBERT OBARSKI**

**WHEREAS**, the Cherry Hill Fire District #13 has a need to acquire IT Support Services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

**WHEREAS**, the Cherry Hill Fire District #13 has determined and certified in writing that the value of the acquisition will exceed \$17,500; and

**WHEREAS**, the anticipated term of this contract is January 1, 2020 through December 31, 2020; and

**WHEREAS**, Robert Obarski has submitted a proposal indicating he will provide IT Support Services pursuant to the proposal at an hourly rate of \$48.00 not to exceed \$25,000.00; and

**WHEREAS**, Robert Obarski has completed and submitted a Business Entity Disclosure Certification which certifies that Robert Obarski has not made any reportable contributions to a political or candidate committee in Cherry Hill Fire District #13 in the previous one year, and that the contract will prohibit Robert Obarski from making any reportable contributions through the term of the contract; and

**WHEREAS**, the Fire District has determined that funds are available concerning the projected expenditures.

**NOW, THEREFORE, BE IT RESOLVED**, that the Commissioners of Fire District #13 in the Township of Cherry Hill, County of Camden, authorized the Fire District to enter into a contract with Robert Obarski as described herein; and

**BE IT FURTHER RESOLVED** that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution.


