**RESOLUTION TO AUTHORIZE EXECUTION OF COLLECTIVE

AFL-CIO Local No. 3198, Cherry Hill Professional Fire Officers Association, effective January 1, 2020 through December 31, 2023, a copy of which is on file, subject to review of all calculation and appendices and approval of counsel.


