**RESOLUTION AUTHORIZING APPOINTMENT OF POST-OFFER PRE-EMPLOYMENT
PSYCHOLOGICAL SCREENINGS AND PSYCHOLOGICAL EVALUATION SERVICES FOR
THE YEAR 2020**

WHEREAS, there exists a continuing need for Post-Offer Pre-Employment Psychological Screenings and Psychological Evaluation Services to be provided to the Commissioners of Fire District #13 in the Township of Cherry Hill, County of Camden, concerning various responsibilities undertaken by the Commissioners; and,

WHEREAS, the Commissioners are desirous of making an appointment to this position as referenced above for the year of 2020; and,

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*, provides that a governing body may award a contract without public advertising for competitive bidding where the nature of said contract is in the form of a professional service; and,

WHEREAS, the subject resolution providing for the awarding of a contract relative to professional services and the notice of the award of contract shall be available for public inspection; and,

WHEREAS, the Local Public Contract Law, N.J.S.A. 40A:11-5(1)(a)(i), provides that a notice of the award of said contract shall be published in a newspaper, said advertisement stating the nature, duration and amount of the contract.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of Fire District #13 in the Township of Cherry Hill, County of Camden, as follows:

Jennifer Kelly, Ph.D., ABPP, is hereby appointed to provide psychological services to the Commissioners relative to any and all issues presented to the Commissioners pursuant to any of its obligations or responsibilities. This appointment is made pursuant to the proposal attached hereto and made a part hereof.


