**RESOLUTION AUTHORIZING CHERRY HILL FIRE DISTRICT #13 STAFF TO PROCESS
AN INVOLUNTARY DISABILITY RETIREMENT APPLICATION**

WHEREAS, Cherry Hill Fire District #13 has employed Daniel T. Brofft as a Firefighter at its 1100 Markkress Road, Cherry Hill, NJ location; and

WHEREAS, Daniel T. Brofft is an active member of the PFRS; and

WHEREAS, Daniel T. Brofft has twenty-two (22) years and five (5) months of PFRS Service Credit, meeting the minimum service credit requirement of at least four (4) years for PFRS members; and

WHEREAS, Cherry Hill Fire District #13's staff is of the opinion that Daniel T. Brofft is totally and permanently disabled and no longer can perform his or her assigned duties based on the documentation supplied by professionals retained by Cherry Hill Fire District #13; and

WHEREAS, Cherry Hill Fire District #13 is unable to provide an alternative to the PFRS covered position with duties capable of being performed by said Daniel T. Brofft; and

WHEREAS, the Board of Fire Commissioners of Cherry Hill Fire District #13 have consented to the processing of the Involuntary Disability Retirement application;

NOW, THEREFORE, BE IT RESOLVED BY the governing body of this location that the administrator of Cherry Hill Fire District #13 process an Involuntary Disability Retirement application for Daniel T. Brofft at its 1100 Markkress Road location; and

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be forwarded to all parties involved in the administration of this action.
