RESOLUTION CONSENTING TO AN AWARD FOR SOLID WASTE AND RECYCLING SERVICES THROUGH THE COOPERATIVE PRICING SYSTEM OF CHERRY HILL

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, has a need for solid waste and recycling collection services; and

WHEREAS, the Fire District is a member of the Cooperative Pricing System of Cherry Hill which periodically obtains pricing for solid waste and recycling collection services for its members; and

WHEREAS, the Cherry Hill Township, as the lead agency, received and opened a bid on August 18, 2020 for solid waste and recycling collection services which included the services needed by the Fire District; and

WHEREAS, the bids were evaluated by the township's Director of Public Works and their Purchasing Agent and an award has been recommended for the lowest responsible bidder, Republic Services of NJ, LLC, 4100 Church Road, Mount Laurel, NJ 08054, for their bid option 10; and

WHEREAS, bid option 10 included providing solid waste and recycling services specifically needed by the Fire District at a total cost of \$50,863.00 during the five-year contract; and

WHEREAS, the Cooperative Pricing System requires the Board of Fire Commissioners to adopt a resolution approving the award of the Fire District's individual services;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey consents to the Fire District's portion of the solid waste and recycling collection services contained in bid option 10 which will run from January 1, 2021 to December 31, 2026; and

BE IT FURTHER RESOLVED, that the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey intends to enter into a separate contractual obligation with Republic Services of NJ, LLC, subject to the necessary funds being appropriated each fiscal year.


