**WHEREAS**, Fire Commissioner Robert A. Campagna has served the Township of Cherry Hill with the Cherry Hill EMS Service since 1970 holding positions of EMT-D, Lieutenant, Captain and President; and

**WHEREAS**, the Board of Fire Commissions of Fire District #13 named Robert A. Campagna as their liaison during the transition of the Cherry Hill Township EMS service into Cherry Hill Fire District #13 in 2003; and

**WHEREAS**, Fire Commissioner Robert A. Campagna has been supportive of the Cherry Hill Fire & EMS Department in its quest to receive an ISO rating of #1 and become an Accredited Fire Agency by the Commission of Fire Accreditation International; and

**WHEREAS**, Fire Commissioner Robert A. Campagna has decided to not seek reelection to the Board of Fire Commission after serving as Fire Commissioner for twenty-six years.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey that the Board of Fire Commissioners is hereby authorized to name the EMS Training Academy at Cherry Hill Fire Headquarters after Fire Commissioner Robert A. Campagna for his dedication to the Fire and EMS services of Cherry Hill Township.


