**RESOLUTION AUTHORIZING CHANGE ORDER #3 FOR BUILDING AND SITE
DEMOLITION FOR 524 BEECHWOOD AVENUE, BID #LOG19-01**

WHEREAS, N.J.A.C. 5:34-4, the Local Public Contracts Laws Administrative Code, requires that any amendments to a construction contract resulting from a Change Order be authorized by governing body resolution; and

WHEREAS, the Cherry Hill Fire District #13 entered into a contract with "The Original" W. Hargrove Demolition Co., Inc. on April 10, 2020 for Project #LOG19-01, Building and Site Demolition for 524 Beechwood Avenue; and

WHEREAS, during demolition a 6,800 gallon underground storage tank was discovered where a 500 gallon underground storage was anticipated which required the removal and disposal of 197.76 tons of non-hazardous waste soil; and

WHEREAS, the work described in the attached Change Order Request #3 has been reviewed and approved by the Project Engineer and the contractor has agreed to the changes in writing, as indicated by the attached change order form dated November 12, 2020;

NOW, THEREFORE, BE IT RESOLVED that the Project Engineer is hereby authorized to execute changes to the April 10, 2020 contract between "The Original" W. Hargrove Demolition Co., Inc. and the Cherry Hill Fire District #13 as follows:
