**RESOLUTION AUTHORIZING ORDERING OF FIREFIGHTER THERMAL IMAGING
CAMERAS AND ACCESSORIES WITH TRADE IN**

WHEREAS, the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, has determined that a need exists to order Firefighter Thermal Imaging Cameras and Accessories with Trade In and with funding provided by a U.S Department of Homeland Security Grant for use by the Department; and

WHEREAS, the Fire District is a member of the State of New Jersey Department of Treasury, Division of Purchase and Property state contact NJSTART, which can be utilized to order Firefighter Thermal Imaging Cameras and Accessories through their fair and open process that satisfies the requirements of the Local Public Contracts Law, N.J.S.A. 40A:11 et seq. without further competitive bidding; and

WHEREAS, the Firefighter Thermal Imaging Cameras and Accessories with various published and unpublished options described meets the standards, specifications and requirements of the Cherry Hill Fire Department;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, that an order for Firefighter Thermal Imaging Cameras and Accessories with Trade In, in the amount not to exceed \$95,850.00 per Assistance to Firefighters grant, be placed with Witmer Public Safety Group, 104 Independence Way, Coatesville PA 19320 under the provisions of the State of New Jersey Department of Treasury, Division of Purchase and Property State Contact NJSTART Contract # 20-Fleet-01118, Vendor ID # V00004434

BE IT FURTHER RESOLVED that this order will be funded using funding provided by a Cherry Hill Fire District Budget.


