JANUARY 1, 2021 TO DECEMBER 31, 2021**

WHEREAS, the Annual Budget for the Cherry Hill Fire District #13 for the fiscal year beginning January 1, 2021 and ending December 31, 2021 has been presented for adoption before the Board of Commissioners of the Cherry Hill Fire District #13 at its open public meeting of January 19, 2021; and

WHEREAS, the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

WHEREAS, the adopted budget is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and,

WHEREAS, the Annual Budget as presented for adoption reflects Total Revenues of \$27,884,846.00 which includes amount to be raised by taxation of \$23,664,337.00 and Total Appropriations of \$27,884,846.00; and

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Cherry Hill Fire District #13, at an open public meeting held on January 19, 2021 that the Annual Budget of the Cherry Hill Fire District #13 for the fiscal year beginning January 1, 2021 and ending December 31, 2021 is hereby adopted and, shall constitute appropriations for the purposes stated and authorization of Total Revenues of \$27,884,846.00 which includes amount to be raised by taxation of \$23,664,337.00 and Total Appropriations of \$27,884,846.00; and,

BE IT FURTHER RESOLVED, that the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services.


