**RESOLUTION AUTHORIZING THE PURCHASE OF FIREFIGHTING GEAR**

**WHEREAS**, the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, has determined that a need exists to order Firefighter Turnout Gear; and

**WHEREAS**, the Fire District is a member of the State of New Jersey Department of Treasury, Division of Purchase and Property State Contact NJSTART which can be utilized to order Turnout Gear through their fair and open process that satisfies the requirements of the Local Public Contracts Law, N.J.S.A. 40A:11 et seq. without further competitive bidding; and

**WHEREAS**, the Turnout Gear with various published and unpublished options described meets the standards, specifications and requirements of the Cherry Hill Fire Department;

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, that an order for 16 sets of Turnout Gear, in the amount of \$46,192.00 per MES quote number QT1504111 and, an additional 12 sets purchased with 2021 Port Authority grant funds, Grant # EMW-2021-PU-00237 in the amount of \$34,644.00 per quote number QT1504109 for a total purchase price of \$80,836.00 be placed with Municipal Emergency Services, 66 Firemens Way, Poughkeepsie, NY 12603 under the provisions of the State of New Jersey Department of Treasury, Division of Purchase and Property, State Contact NJSTART Contract #HFRP NJ State Contract 17-Fleet-00810, Quote # 80621NJCHER, Specid: NJCHER00046, Specid: NJCHER00047


