**WHEREAS**, the Fire District #13 is a member of the State of New Jersey Department of Treasury, Division of Purchase and Property state contact NJSTART, which can be utilized to order Computer Equipment through their fair and open process that satisfies the requirements of the Local Public Contracts Law, N.J.S.A. 40A:11 et seq. without further competitive bidding; and
