**RESOLUTION AUTHORIZING THE APPOINTMENT OF PER DIEM
EMERGENCY MEDICAL TECHNICIANS TO FILL EXISTING VACANCY**

WHEREAS, N.J.S.A. 40A:14-81.1 states that the Commissioners of any Fire District may, by resolution, establish paid positions for the Fire District as such positions shall be determined by the Commissioners to be required for the purposes of the Fire District, and;

WHEREAS, the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden has determined that the position of Per Diem Emergency Medical Technician of the Fire District and the salaries and benefits for such positions previously established and agreed upon, has been created and previously established, and;

WHEREAS, the Board of Fire Commissioners has determined that five (5) Per Diem Emergency Medical Technician positions are needed to be filled to continue to promote the safety of the public they serve, and;

WHEREAS, the following requirements must be satisfied in order to continue with this process: Pass a background investigation; Pass a Post Offer Medical Examination, which includes a Hair Follicle Drug Screening Test; complete all required training as directed by the Fire Chief of the Department.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey that the Board of Fire Commissioners is hereby authorized to appoint the following eligible candidates:

The Fire Chief of the Department shall have full and final discretion and authority to conduct this review and make recommendations subject to review and approval by the Board and pursuant to the provisions of N.J.S.A. 40A:14-1 et seq.
