**WHEREAS**, the Fire District #13 in accordance with N.J.S.A. 40A:11-1 et seq., the Local Public Contracts Law, has advertised for bids for the purchase of Flying Cross Nomex Uniforms or Equivalent to establish a ready source for the procurement of these uniforms; and

**WHEREAS**, listed below are the names of the two companies that placed a bid for the purchase of Flying Cross Nomex Uniforms or Equivalent:

- Galls LLC

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, authorizes the award for Flying Cross Nomex Uniforms or Equivalent in accordance with N.J.S.A. 40A:11-1 et seq., the Local Public Contracts Law to the lowest responding bidder Action Uniform Co, LLC for a two (2) year contract on an as needed basis not to exceed the approved budget.


