TREASURER'S REPORT

CFO Foley read the Treasurer's Report into the record; the opening balance in the cash accounts as of September 1 was \$13,692,335.34 which reflected an adjustment of \$10,916.89 due to a missed interest payment in the August Capital Account. September receipts totaled \$2,299,997.33; September disbursements totaled \$1,722,354.42 leaving a closing balance of \$14,280,895.14 as of September 30, 2023, which resulted in a net use of cash totaling \$588,559.80.


