RESOLUTION TO ADOPT A TEMPORARY BUDGET FOR PUBLIC EXPENDITURES

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey recognizes the need for public expenditures to protect and promote the public safety and welfare of its citizens; and

WHEREAS, N.J.S.A. 40A:14-78.16 states that commencing January 1, 1986, a fire district's fiscal year shall begin January 1st and end December 31st; and

WHEREAS, necessary funds are needed for the efficient operation of the fire district until such time that the adopted budget is approved by the Department of Community Affairs; and

WHEREAS, commitments and payments for salaries, goods and services must continue for the efficient operation of the Fire District; and

WHEREAS, a temporary budget needs be adopted prior to January 1, 2024 with total appropriations not exceeding **14%** of the total of the appropriations made for all purposes in the budget for the preceding fiscal year exclusive of appropriations for interest and debt redemption charges and capital improvements.

NOW, THEREFORE, BE IT RESOLVED that the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey in accordance with N.J.S.A. 40A:14-78.17 that a temporary budget be adopted, not to exceed the amount of \$4,201,645.28

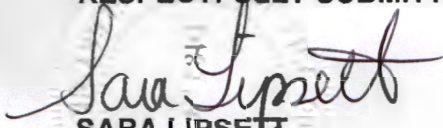
