JANUARY 1, 2024 TO DECEMBER 31, 2024**

WHEREAS, the Annual Budget for the Cherry Hill Fire District #13 for the fiscal year beginning January 1, 2024 and ending December 31, 2024 has been presented for adoption before the Board of Commissioners of the Cherry Hill Fire District #13 at its open public meeting on January 18, 2024; and

WHEREAS, the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

WHEREAS, the adopted budget is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and,

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$32,446,457.63, which includes the amount to be raised by taxation \$26,110,472.00 and Total Appropriations of \$32,446,457.63; and

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Cherry Hill Fire District #13, at an open public meeting held on January 18, 2024 that the Annual Budget of the Cherry Hill Fire District #13 for the fiscal year beginning January 1, 2024 and ending December 31, 2024 is hereby adopted and, shall constitute appropriations for the purposes stated and authorization of Total Revenues of \$32,446,457.63, which includes the amount to be raised by taxation \$26,110,472.00 and Total Appropriations of \$32,446,457.63; and

BE IT FURTHER RESOLVED, that the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services.
