RESOLUTION APPROVING THE ANTICIPATED ITEM OF REVENUE AND APPROPRIATIONS TO THE 2024 FIRE DISTRICT BUDGET – FY23 HAZARDOUS MATERIALS EMERGENCY PREPAREDNESS HAZMAT TRAINING SUBGRANT

WHEREAS, Cherry Hill Fire District #13 has applied for the FY23 Hazardous Materials Emergency Preparedness (HMEP) Training Subaward Grant – CFDA 20.703, Sub-Award Number (2023-05) for the period October 1, 2023-September 30, 2024; and

WHEREAS; Cherry Hill Fire District #13 directs and authorizes Fire Chief Wade Houlihan to act as the official representative of the Fire District in connection with the application and to provide such additional information as may be required.

NOW, THEREFORE, BE IT RESOLVED, that Fire District #13 of the Township of Cherry Hill in the County of Camden, State of New Jersey, hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2024 in the sum of \$19,966.67, which is now available from the U.S. Department of Transportation through the New Jersey Department of Law and Public Safety, Division of State Police, Office of Emergency Management.
