**RESOLUTION APPROVING ENTERING INTO A MODIFICATION AGREEMENT TO THE
LEASE FOR AMBULANCE PROJECT #EMS2020-002**

WHEREAS, the Board of Fire Commissioners, Fire District #13, has approved a bid award for a 48-month lease with Leasing 2, Inc. to arrange an operating lease for two ambulances per a project entitled Operating Lease for Ambulance - Project #EMS2020-002 with total payment of \$410,632.80; and

WHEREAS, Leasing 2, Inc. has provided an executable Master Lease and Supplements which identifies Wells Fargo Equipment Finance, Inc., NW-8178, P.O. Box 1450, Minneapolis, MN 55485-8178 as the true Lessor for the lease under contract #001-1413711-108; and

WHEREAS, due to unforeseen delivery delays in receiving the replacement ambulances, the current Lease must be modified to add an additional 12 months to the original lease at a monthly cost of \$6,038.82 beginning July 24, 2024 as per the Modification Agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey hereby authorizes the Chief Finance Officer to execute a Modification Agreement with Wells Fargo Equipment Finance, Inc., NW-8178, P.O. Box 1450, Minneapolis, MN 55485-8178 as the lessor and to acknowledge and deliver the Modification Agreement with any changes, insertions and omissions therein as may be approved by the Officer and such approval to be conclusively evidenced by such execution and delivery of the Modification Agreement.

BE IT FURTHER RESOLVED that this agreement shall be subject to and dependent on the annual appropriation of sufficient funds as may be required to meet this obligation.

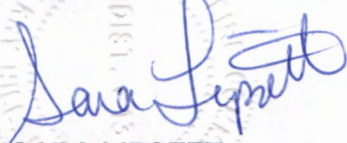
