**WHEREAS**, the International Association of Firefighters Local 2663 has requested that the Board of Fire Commissioners, Cherry Hill Fire District #13, voluntarily recognize the union as the sole and exclusive Bargaining Agent for the aforesaid employees, and

**WHEREAS**, the International Association of Firefighters Local 2663 has provided the requisite showing of interest in support of its request.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, that

- A. The Board of Fire Commissioners, Cherry Hill Fire District #13, recognizes the International Association of Firefighters Local 2663, AFL-CIO-CLC as the sole and exclusive Bargaining Agent for its full-time paid mechanic employees.
- B. All others, including firefighters and fire officers represented by the International Association of Firefighters Locals 2663 and 3198, police, other non-fire suppression employees, confidential employees, craft employees, professional employees and managerial executives within the meaning of the New Jersey Public Employer-Employee Relations Act (hereinafter "The Act) shall be excluded from this bargaining unit.


