DISCUSSION ITEMS

- BC Reis updated the Board on the current training initiatives that are taking place this month such as the Hi-Rise and Flashover training taking place at the Burlington County Fire Training Academy, the FOAP class, Chauffer training and Haz-Mat drills that were conducted in Winslow Township. The fourth quarter testing for the probationary firefighters is currently under way. BC Reis briefed the Board on the recent working fires handled by the Department; he also reported that the specifications for the new engine have been submitted to the Office of the Chief.
- Fire Chief Houlihan reported that progress has been made with Maple Shade Fire Department. The Township has reestablished the fire department and it is expected that they will begin handling their own calls for service this month at which time CHFD will go back to the normal response protocols for Maple Shade.

Fire Chief Houlihan reminded the Board that the first class of probationary firefighters are scheduled to take their Oath of Office at the regular meeting on May 16 at 1900 hours.

Fire Chief Houlihan thanked the Board members who have interacted with the on-duty crews, it is very much appreciated.


