**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR
LEGAL SERVICES WITH THE LAW OFFICE PARKER McCAY P.A.**

WHEREAS, the Cherry Hill Fire District #13 has a need to acquire legal services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate; and

WHEREAS, the Cherry Hill Fire District #13 has determined and certified in writing that the value of the acquisition will exceed \$17,500; and

WHEREAS, the anticipated term of this contract is for the year January 1, 2025 through December 31, 2025; and

WHEREAS, the Law Office of Parker McCay P.A. has submitted a proposal indicating it will provide the legal service pursuant to the proposal at an hourly rate of \$270.00 per hour for Shareholders (Partners), Of Counsel and Associates and \$95.00 per hour for Paralegals/Law Clerks not to exceed \$40,000.00; and

WHEREAS, the Law Office of Parker McCay P.A. has completed and submitted a Business Entity Disclosure Certification which certifies that the Law Office of Parker McCay P.A. has not made any reportable contributions to a political or candidate committee in Cherry Hill Fire District #13 in the previous one year, and that the contract will prohibit the Law Office of Parker McCay P.A. from making any reportable contributions through the term of the contract; and

WHEREAS, the Fire District has determined that funds are available concerning the projected expenditures.

NOW, THEREFORE, BE IT RESOLVED, that the Commissioners of Fire District #13 in the Township of Cherry Hill, County of Camden, authorized the Fire District to enter into a contract with the Law Office of Parker McCay P.A as described herein; and

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution.


