**RESOLUTION AUTHORIZING THE ADVERTISING OF BIDS FOR
AN AMBULANCE OPERATING LEASE, PROJECT #EMS 2025-001**

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey has determined that they will advertise for sealed bids for a bid entitled Operating Lease for Ambulance, Project #EMS 2025-001 and;

WHEREAS, the current lease for ambulance Unit #18 (Asset #400374), per Resolution #24-04-18-03 modification agreement, will expire to coincide with the tentative late-Summer delivery date of this previously ordered ambulance barring delays caused by supply chain issues and;

NOW, THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, authorizes the Purchasing Manager as follows:

1. Prepare detailed specifications for this project and provide same to assure that the services will be obtained through a fair and open process and will meet the functional and operational needs of Fire District #13.
2. The Purchasing Manager shall advertise and receive sealed bids for the above-named purpose or project at the appropriate time when the ambulance delivery date is secured.

BE IT FURTHER RESOLVED, that the governing body of the Board of Fire Commissioners, Fire District #13 pursuant to N.J.A.C 5:30-5.5(b), the certification of available funds, shall either certify the full maximum amount against the budget at the time the contract is awarded, or no contract amount shall be chargeable or certified until such time as the goods or services are ordered or otherwise called for prior to placing the order and a certification of availability of funds is made by the Chief Financial Officer.

BE IT FURTHER RESOLVED that a Certified copy of this resolution shall be uploaded in FAST for the Director of the Division of Local Government Services for the certification of the 2025 Fire District Budget as so amended.


