RESOLUTION AUTHORIZING THE ISSUANCE OF A CONTRACT FOR CYBERSECURITY SOLUTIONS AND ASSOCIATED PRODUCTS AND SERVICES

WHEREAS, the Division of Local Government Services allows local contracting units to utilize national cooperative contracts as a method of procurement, pursuant to LFN 2012-10 dated May 14, 2012, P.L. 2011, c.139 (the "Law" or "Chapter 139"), without advertising for bids in accordance of N.J.S.A. 52:34-6.2(b); and

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey has the need for cybersecurity solutions and associated products and services; and

WHEREAS, the Board of Fire Commissioners, Fire District #13 is a member of the Omnia Partners national service cooperative; and

WHEREAS, the Board of Fire Commissioners, Fire District #13 intends to enter into the Omnia Partners contract R200803 with TD Synnex and their approved subcontractors on an as-needed basis through this resolution and properly executed contracts, which shall be subject to all the conditions applicable to the current State law, rules and regulations, and;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, authorizes the issuance of a contract for a two-year period or the expiration of the cooperative contract, whichever occurs first, for Cybersecurity Solutions and Associated Products and Services to TD Synnex and their approved subcontractors.
