**RESOLUTION AUTHORIZING THE DISPOSAL OF A SURPLUS VEHICLE
NO LONGER NEEDED FOR PUBLIC USE**

WHEREAS, the Fire District from time to time has equipment and other materials which become unusable by the organization due to obsolescence, wear and tear, or other reasons which must be disposed of as surplus property; and

WHEREAS, the Camden County Foam Task Force and the Cherry Hill Fire Department has determined that the **2012 Freightliner/Crimson Foam Tender, VIN # 1FHG3DV4DDBW6534**, owned by the Fire District has become surplus and is no longer needed for public use; and

WHEREAS, the estimated fair market value established for this property exceeds 15 percent of the bid threshold which requires that this surplus item be sold through public sale to the highest bidder in accordance with the requirements of the Local Public Contracts Law, NJSA 40A:11-36;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Fire Commissioners, Fire District #13, hereby authorizes the public sale of the surplus **2012 Freightliner/Crimson Foam Tender, VIN # 1FHG3DV4DDBW65342005**, to the highest bidder(s) in accordance with the terms and conditions established for the sale, sold "as is" and with no warranties implied.

BE IT FURTHER RESOLVED, that a notice of date, time and place of the public sale together with a description of the items to be sold and the conditions of sale shall be published in the Courier Post not less than seven or more than fourteen days prior to the sale.
