**RESOLUTION AUTHORIZING THE AWARD OF PROFESSIONAL SERVICE RISK
MANGEMENT CONSULTANT**

WHEREAS, the Cherry Hill Fire District #13 has a need to acquire a Risk Management Consultant as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate; and

WHEREAS, the anticipated term of this contract is February 1, 2026 through January 31, 2029; and

WHEREAS, Conner Strong and Buckelew has submitted a proposal indicating it will provide Risk Management Consultant services pursuant to the Cherry Hill Fire District #13 specifications; and

WHEREAS, Conner Strong and Buckelew has completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Cherry Hill Fire District #13 during the previous one year, and that the contract will prohibit them from making any reportable contributions through the term of the contract; and

WHEREAS, the Fire District has determined that funds are available concerning the projected expenditures.

NOW, THEREFORE, BE IT RESOLVED, that the Commissioners of Fire District #13 in the Township of Cherry Hill, County of Camden, authorized the Fire District to enter into a contract with Conner Strong and Buckelew as described herein; and

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification be placed on file with this resolution.
