RESOLUTION AUTHORIZING THE CHERRY HILL FIRE DISTRICT #13 TO PARTICIPATE IN THE DEFENSE LOGISTICS AGENCY DISPOSITION SERVICES PROGRAM TO ACQUIRE EXCESS DEPARTMENT OF DEFENSE EQUIPMENT

WHEREAS, the United States Federal Government through the Defense Logistics Agency (DLA) offers a Reutilization, Transfer, Donation (RTD) for Disposition services program to make use of excess Department of Defense serviceable property by making that property available to additional agencies; and

WHEREAS, participation in DLA's RTD program allows the Fire District to obtain property they might not otherwise be able to afford in order to enhance fire protection and emergency medical services, as well as the general operations of the Fire District; and

NOW, THEREFORE BE IT RESOLVED, that the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey authorizes the Fire District to participate in the DLA's disposition services program.

BE IT FURTHER RESOLVED that the governing body of the Board of Fire Commissioners, Fire District #13 pursuant to N.J.A.C 5:30-5.5(b), the certification of available funds, shall either certify the full maximum amount against the budget at the time the contract is awarded, or no contract amount shall be chargeable or certified until such time as the goods or services are ordered or otherwise called for prior to placing the order and a certification of availability of funds is made by the Chief Financial Officer


