**RESOLUTION TO AUTHORIZE EXECUTION OF COLLECTIVE  
BARGAINING AGREEMENT WITH I.A.F.F. CIO/CLC LOCAL 3249

AFL-CIO Local No. 3249, Cherry Hill Emergency Medical Technicians and Paramedics, effective January 1, 2025 through December 31, 2028, a copy of which is on file, subject to review of all calculation and appendices and approval of counsel.


