**RESOLUTION AUTHORIZING THE DISPOSAL OF SURPLUS VEHICLE

**WHEREAS**, the Fire District from time to time has equipment and other materials which become unusable by the organization due to obsolescence, wear and tear, or other reasons which must be disposed of as surplus property; and

**WHEREAS**, the disposal of surplus property with an estimated fair market value that exceeds 15 percent of our bid threshold, which is currently \$6,000.00, must be disposed of through public sale to the highest bidder in accordance with the requirements of the Local Public Contracts Law, NJSA 40A:11-36; and

**WHEREAS**, It has been determined that the fire district owned **1996 Ford F-450 Utility Truck, VIN 1FDLF47F7TEA06944**, has become surplus and has a fair market value that exceeds 15 percent of our bid threshold;

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Fire Commissioners, Fire District #13, hereby authorizes the public sale of the said **1996 Ford F-450 Utility Truck, VIN 1FDLF47F7TEA06944**, in accordance with the terms and conditions that will be established for the sale, sold "as is" and "where is" with no warranties implied.

**BE IT FURTHER RESOLVED**, that a notice of date, time and place of the public sale together with a description of the item to be sold and the conditions of sale shall be published in the Courier Post not less than seven or more than fourteen days prior to the sale.
