**RESOLUTION TO AUTHORIZE EXECUTION OF COLLECTIVE  
BARGAINING AGREEMENT WITH I.A.F.F. CIO/CLC LOCAL 2663**

AFL-CIO Local No. 2663, Cherry Hill Professional Firefighters Association of Fire District #13 in Cherry Hill Township have entered into negotiations for a collective bargaining agreement; and

**WHEREAS**, the Board of Fire Commissioners for Fire District #13 and the I.A.F.F. AFL-CIO Local No. 2663, Cherry Hill Professional Firefighters Association have concluded negotiations for a collective bargaining agreement effective January 1, 2016 through December 31, 2019; and

**WHEREAS**, the Board of Fire Commissioners for Fire District #13 and the I.A.F.F. AFL-CIO Local No. 2663, Cherry Hill Professional Firefighters Association, desire to implement said collective bargaining agreement as quickly as possible;

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, hereby approves and is authorized to execute a collective bargaining agreement with I.A.F.F. AFL-CIO Local No. 2663, Cherry Hill Professional Firefighters Association, effective January 1, 2016 through December 31, 2019, a copy of which is on file, subject to review of all calculation and appendices and approval of counsel.
