WHEREAS, the Board of Fire Commissioners for Fire District #13 and the Board of Fire Commissioners of Evesham-Fire Rescue recognize that entering into an agreement for mutual aid and assistance with each other to protect against loss, damage or destruction by fire, catastrophe, civil unrest, major emergency or other extraordinary devastation and to address those situations when additional aid and assistance is needed to protect the best interest of the persons and property in their jurisdiction; and

WHEREAS, the statutes of the State of New Jersey authorize interested parties to enter into an agreement relative to the providing of these services.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, hereby approves and is authorized to execute a Mutual Aid and Assistance Agreement with the Board of Fire Commissioners of Evesham Fire-Rescue, Evesham Township, County of Burlington, State of New Jersey.
